# Main Duties And Responsibilities

### Behavioural:

- Provide team leadership, strengthening engagement, growth, culture, innovation, collaboration, and performance.

- Management of collections staff including oversight of work programmes and mentoring staff to support their professional development.
- Ensuring oversight and management of the curatorial programme to meet budgetary needs reporting to the Museums Manager.
- Contribute to the formulation of budgets and forecasts for exhibition costs, working closely with the Museums Manager.
- Contribute to Museums strategy, workign closely with the Front of House and Museums Manager.









### Exhibitions, Commissions, and Projects:

- Working with the Museums Manager, you will oversee the delivery of multi-disciplinary exhibitions, commissions and projects across a range of topics and media.
- Research and develop project proposals and ideas, as well as potential collaborative opportunities with guest curators, in keeping with the exhibition strategy.
- Write informative and accessible interpretation.
- Work with guest curators/artists/creatives as a co-curator, helping to shape and realise their visions into ground-breaking, accessible and relevant exhibitions.
- Maintain networks with artists, curators, creative colleagues and peer organisations to help build partnerships for Wirral Museums.
- Develop and deliver initiatives to engage wide and diverse audiences.

### **Collections Care:**

- Identify and negotiate loans with artists, galleries, museums, and private institutions.
- Monitor environmental conditions within museum buildings.
- Where appropriate, commission conservation on items in Wirral Museums collections.
- Have oversight of collections research, contributing directly where it supports exhibition development and interpretation.
- Ensure due diligence on provenance and work values where required.
- Support the exhibitions programme through talks, tours, events and other public programmes for a variety of audiences.
- Propose individual items for acquisition or areas for collection development, in line with the Collection Development Policy.
- Support the Museums Manager in the strategic planning for the Service and preparing Accreditation documentation.
- If required, act as courier for items from Wirral Museums collections, overseeing transport and handling while on loan.
- Contributing to audits as required.

### **Compliance:**

- Adhere to and comply with all relevant corporate policies and procedures including Health & Safety, General Data Protection Regulations (GDPR), Corporate Governance and Code of Conduct.
- Ensure that all service initiatives adhere to relevant legislation, policies and practices.

### Other:

- Undertake any specialist and/or general training as required by the post.
- Respond as practicable to emergencies affecting Wirral Museums collections on all sites.
