This will include contribution to curriculum development and lesson plans as well as assisting in the preparation, delivery and assessment of learning.

To support tutors in delivery of learning activities/programmes, within the classroom and the community, appropriate to the individual outcomes and needs of individual learners.</p> <p>10. To ensure tutors are informed of learner achievement/progress and record accurately on a daily basis.</p>

To record progress and achievement in lessons/activities, providing contextualised evidence of the progress.</p> <p>21. To file and store records of progress, ensuring the availability of appropriate evidence when required.</p>

Additional Duties	<p>27.
