Purpose

Responsible for supporting the delivery of health and social care functions for adults/carers for the people of wirral. A key role in supporting the delivery of the personalisation and inclusion pathways for adults and carers ensuring legal framework of the Care Act 2014, strength and asset-based practice, personalisation and social inclusion is embedded and applied effectively. Assessing, accessing, and implementing a range of Social Care services, and providing guidance/advice and information for adults with acute or increasingly complex long term physical health, mental health needs and for older people and carers.

Main Duties And Responsibilities

Behavioural:

- Enjoy, achieve, create impact, and thrive in the role and organisation.
- Live our values in the role and organisation.

Adult Social Care specific duties & responsibilities:

- To undertake comprehensive assessments and reviews of daily living tasks. The focus being personalised individualised care planning identifying achievable goals through the means of Reablement and maximising independence.
- Undertake statutory social care assessments and assessments of eligibility for funded services in line with current legislation. Interpret and discuss assessment outcomes with people, their carers, other health and social care professionals and the voluntary sector to agree care plans. Identify risks to independence and work alongside individuals and carers to develop outcome focused support plans.
- Support people to be as independent as possible by facilitating a range of self-management strategies through identifying the most appropriate format. Including the support that is available from the voluntary and community sector. Commission services as appropriate in line with current delegation policies, ensuring effective use of resources.

Communication, Engagement and Training:

- Support the team to establish effective working relationships with people, their families and carers. This will include promoting individual rights and recognising and respecting their contributions to care and support planning and delivery.
- Work collaboratively with identified agencies in commissioning and reviewing Functional assessments by evidencing risk and risk avoidance of potential needs.
- Participate in programmes of training and associated work experience and appraisal for career progression.
- Participate in multidisciplinary/multi-agency working as appropriate to the role and level.

Data Analysis and Decision-Making:

- Participate in collation of analytical performance management information.
- Record and report practice, service provision and decision making and access and use management information systems, ensuring compliance with statutory, Wirral Council and local multi-agency requirements.

Compliance:

 Adhere to and comply with all relevant corporate policies and procedures including Health & Safety, General Data Protection Regulations (GDPR), Corporate Governance and Code of Conduct.

- Understanding of the needs of older people / adults with disabilities/long term conditions/ health problems particularly in relation to promoting their independence.

- Ability to work with other professionals/service users/carers/families and promote partnership working.
- Ability to write reports and maintain records.
- Ability to contribute to service development and wide health and social care agendas.
