# Purpose

Act as passenger assistants on home to school transport for children with special educational needs and/or disabilities attending schools and bases. Supervising children to ensure their health and safety whilst travelling on vehicles contracted to the Authority.

# Main Duties And Responsibilities

#### Behavioural:

- Enjoy, achieve, create impact, and thrive in the role and organisation.
- Live our values in the role and organisation.

# **Communication, Engagement and Training:**

- Ensure that the conduct of the children, whilst on the vehicle, does not put anyone at risk and to report any disruptive behaviour to the Transport section and to the Headteacher.
- Submit written reports to the Transport section of any incidents as mentioned above.

# Compliance:

- Ensure children are collected from and returned to their home addresses and are handed over to a parent or responsible adult.
- Ensure that on journeys parents pass money, valuables and any medicines to you for safe keeping and that these are handed into school.
- Notify the Transport section if you are unable to carry out your journey. Passenger Assistants must not arrange their own standby cover.
- Adhere to and comply with all relevant corporate policies and procedures including Health & Safety, General Data Protection Regulations (GDPR), Corporate Governance and Code of Conduct.

#### Other:

- Contact the Transport section if difficulties are experienced with your assigned contractor.
- Any other duties commensurate with the grade.
