# **Purpose**

To ensure the safe transportation of vulnerable service users to and from schools, day centres, colleges and other establishments.

The role will require the post holder to carry out the driver's duties and at other times the attendant duties.

# Main Duties And Responsibilities

## Behavioural:

- Enjoy, achieve, create impact, and thrive in the role and organisation.
- Live our values in the role and organisation.

## Communication, Engagement and Training:

- To drive a vehicle or carry out the attendant duties whilst transporting clients with varying needs including learning disabilities, social, physical, mental health and/or medical conditions. To ensure all wheelchairs are safely secured and all safety equipment is utilised.
- Assisting service users at the beginning, during and at the end of their journeys to ensure safe and comfortable transportation.

## Compliance:

- Adhere to and comply with all relevant corporate policies and procedures including Health & Safety, General Data Protection Regulations (GDPR), Corporate Governance and Code of Conduct.
- To report any incidents to the Assisted Travel Office.

## Other:

• Any other duties commensurate with the grade.

Flexibility to carry out duties outside of normal working patterns as and when required.
