Purpose of the Job

Under the direction of the management team, you will ensure that the needs of adults referred to Adult Social Care are assessed and identified, met, safeguarded and monitored in accordance with the requirements of the Care Act 2014 and Knowsley’s safeguarding policy and procedures.

You will carry a workload reflecting increasing complexity, risk, uncertainty and challenge in line with the capability of an experienced Social Worker.

Duties and Responsibilities

This is not a comprehensive list of all the tasks, which may be required of the post holder. It is illustrative of the general nature and level of responsibility of the work to be undertaken.

With support of your supervisor, enhanced supervision schedule and reduced caseload you will be expected to undertake this level of work at the appropriate time during the course of your Assessed and Supported Year in Employment (ASYE):

1. Promote the welfare and safeguarding of adults in Knowsley.
2. Carry out strength-based, person centred assessment and support planning under the Care Act 2014
3. Carry out safeguarding enquiries under Section 42 of the Care Act 2014
4. Undertake risk assessments and risk management planning



5. Have a good level of legal literacy and effectively use legislation and frameworks including The Care Act (2014), The Mental Capacity Act (2005), Mental Health Act (2007) and associated statutory guidance to ensure the team are compliant with statutory duties.
6. Ensure all work carried out promotes the participation and engagement of all relevant agencies, the adult and their family.
7. Ensure maintenance of records in accordance with good practice, professional codes, and organisational standards
8. Contribute to the well-being of the team by supporting other team members and treating all colleagues with dignity and respect.
9. Take part in regular supervision and appraisal and undertake all mandatory training requirements of the role
10. Any other duties (commensurate with the grade) which will assist the Service in meeting its objectives.
11. Contribute to emergency planning arrangements and demonstrate flexibility in responding to unforeseen circumstances, including supporting service delivery during emergencies or disruptions.
12. Willingness to work flexibly from any location determined by the Authority, when required evenings and weekends in accordance with the flexibility agreement in place
